Executive Director's Message

Dear Community Members,

We are excited to present you with our 2019-2020 Annual Report.

Like the rest of the world, Shasta Head Start has made many changes this year while adapting to the COVID-19 pandemic. It has been difficult to reduce class sizes and limit

in person services to meet health guidance. I appreciate the effort our parents, staff, and community partners have made to provide the best possible services to families under the current conditions.

In adapting our services, we have invested substantially in our information technology infrastructure to serve families remotely. In addition, we have provided personal protective equipment, diapers, meals, and activity packets for families.



The unexpected hurdles this year have not stopped our progress to support children and families. We are making strides in implementing the Teaching Pyramid Framework to improve social and emotional development and prevent challenging behavior in the classroom. We hope to open a new Burney center by fall of 2021. We also changed the location of our Yreka center to a nearby, beautifully remodeled site.

I look forward to another great year serving the children and families of Shasta, Siskiyou, and Trinity Counties.

Pandemic Response

Shasta Head Start staff worked relentlessly to continue serving children and families during the COVID-19 outbreak and the stay at home orders. We collaborated with county and state guidelines to ensure the safety of children, families, and staff. Since then, we have been able to serve families via distance learning and with reduced capacity in the classroom, continuing to prioritize health and safety. We have tracking systems in place for all COVID exposures and help families with quarantine, symptom tracking, and identifying when the child may return to the classroom.

Distance Learning:

100% of distance learners were offered a resource filled Activity Bag every 2 weeks.

The number of parents using our communication app (Learning Genie) grew 249%

1348 school readiness activities were sent to parents March 2020-December 2020.

40 diapers and 100 wipes were distributed to EHS families every 2 weeks.

730 meals were distributed to distance learners in September 2020-December 2020.

Reopening:

Shasta Head Start began gradually reopening centers on July 8th, 2020. Additional supplies, teacher trainings, and resources were provided to ensure the safety of all.

Federal & State Reviews

ENVIRONMENTAL HEALTH AND SAFETY REVIEW

From 4/20/2015 to 4/24/2015, the Administration for Children and Families conducted an Environmental Health and Safety review event for Shasta County Head Start Child Development, Inc. Based on the information gathered, no area of noncompliance was found during the course of the review.

FISCAL/ELIGIBILITY RECRUITMENT SELECTION ENOLLMENT ATTENDANCE REVIEW

From 5/18/2015 to 5/22/2015, the Administration for Children and Families conducted a Fiscal/ERSEA review event for the Shasta County Head Start Child Development, Inc. Based on the information gathered, **no area of non-compliance** was found during the course of the review.

STATE REVIEW

From 10/5/2015 to 10/8/2015, the California Department of Education conducted an overall program review of the CSPP and CCTR program including: fiscal, governance, administration, involvement, staffing, professional development, teaching and learning. Corrections in two areas were met and cleared on 6/2/2016.

LEADERSHIP GOVERNANCE MANAGEMENT SYSTEMS REVIEW

From 5/23/2016 to 5/24/2016, the Administration of Children and Families conducted a LGMS review event for Shasta County Head Start Child Development, Inc. Based on the information gathered, **no** area of non-compliance was found during the course of the review.

FOCUS AREA ONE REVIEW

From 11/18/2019 to 11/22/2019 the Head Start Focus Area One Review was conducted by the Office of Head Start. The review was conducted through a series of interviews with management staff discussing program design, management, and governance structure to the Federal Reviewer. Based on the information gathered, no area of noncompliance was found during the course of the review.

CLASS REVIEW

From 2/03/2020 to 2/8/2020, the Administration for Children and Families observed preschool center-based classrooms using the Classroom Assessment Scoring System. The tool looks at three domains and ten dimensions of teacher-child interactions and measures those observed interactions on a seven point scale. Based on the information gathered, no area of non-compliance was found during the course of the review.


Actual expenditures and revenue for fiscal year 2018-2019 were \$14,185,430 compared to the budget of \$14,185,430. Expenditures consist of personnel, travel, equipment, supplies, and contractual cost necessary for the operation of a Head Start program. All expenditures for the fiscal year met the cost requirement set forth in CFR 45 Part 75.

The Financial Audit for Fiscal Year 2020 was completed with no reportable findings.



Enrollment

In 2019-2020, a total of **902** children and families were served, the average monthly enrollment was **94%**, and an estimated **43%** of eligible children in our service area were served!





Children with disabilities or mental health concerns are encouraged to participate in SHS program services. Appropriate accommodations, enhancements, and support is provided as needed for each child.




- 11.7% of HS children served had an IEP (Individualized Education Program).
- 17.4% of EHS children served had an IFSP (Individualized Family Service Plan).

Health & Nutrition

All families participating in the program are encouraged to complete required medical and dental exams through health care and oral health care professionals.

Every child in the program receives a nutritional evaluation upon entry to determine individual nutritional needs.






Percentage of enrolled children ages 3-5 that completed dental exams:

A total of 345 individual child nutrition plans were developed and fully supported by SHS.

Family Engagement

Family engagement is a vital component in the structure and function of the Head Start program. Families are involved in program governance, program planning, curriculum development, child homework, and personal development. Family Workers and Home Visitors work with families to establish individualized family goals, and help families complete their goals. Below is a graph showing goals completed by type of goal.

Parent Engagement Activities

One of Shasta Head Start's primary goals is to help families participate in their child's education as well as in their own personal growth and development. Shasta Head Start offers both Parent Meetings and Parent Cafés. Parent Meetings provide opportunities for families to build supportive relationships. Parent Cafés are focused on enhancing relationships, practicing positive communication skills, and promoting healing. SHS also offers Make Parenting A Pleasure, an evidence-based parenting curriculum that is effective in improving

outcomes for stressed families. All parent engagement activities took place prior to the COVID-19 stay at home order in March 2020. For the safety of our children, families, and staff, in-person activities were not offered for the rest of the program year.



267 Parents/Guardians received parenting education!

122 father figures participated in program activities.

School Readiness Goals


School readiness goals are determined by the agency for each age group. Children are assessed three times per year using the State of California DRDP rating tool. The following depicts the school readiness goal outcomes over the Fall 2019 and Winter 2019 rating periods, and the percentage of children who met or exceeded school readiness expectations by measure for their age. Due to stay at home orders in the Spring of 2020, only Fall 2019 and Winter 2019 data was collected.

Total Number of Assessments:

Fall 2019: 301 infants and toddlers, 373 preschoolers


Winter 2019: 297 infants and toddlers, 383 preschoolers

Family Child Care Option

Our Family Child Care (FCC) program offers extended day child care for Early Head Start children up to the age of four in a comfortable home environment.

Our current Family Child Care
Provider partners have
extensive Early Childhood
experience and education, and
several are currently accredited
with the National Association
of Family Child Care. Our



partners use the same high quality Creative Curriculum as the centers and, along with all center teaching staff, are also learning about Teaching Pyramid and Second Step as tools to support the social-emotional growth of the children in our care.

Our FCC Department conducts bi-monthly visits and annual monitoring of each Providers program to assure quality of services for Head Start children and families, as well as ongoing support.

Community Partners

Community partners are essential in helping to enrich the fundamental services families need. We have highlighted just a few of the many events and activities that we appreciated last year.



Shasta Community Health Center Dental Clinic

The clinic provided free dental exams for enrolled families!

36 children received exams.

13 children were referred for follow-up.

Lions Club Group 4-C1

The Lions Club conducted vision screenings in Shasta, Siskiyou, and Trinity County!

- 459 children were screened within the first 45 days of entry.
- 45 children were referred for further evaluation.
- 17 children received further treatment.
